9	that the pay structure/fee structure fixed by the Governing body shall got approved by the District Educational Officer or nominee every year.
10	that all the conditions prescribed in the G.Os. and other orders which are not specified in this order shall be complied with. Otherwise the permission will be cancelled.
11	that the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least 6 months before.
12	that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13	that the society shall submit proposals for Temporary Recognition sufficiently in advance as per G.O.Ms.No.1, Edn., dated:1-1-94.
14	The above Provisional Recognition is subject to a written undertaking being given by the school Management that the recognition purely on temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the pre-requisite conditions under the A.P. Education Act, 1982 and if later found that the school has not fulfill any prerequisite as stipulated, the Provisional Recognition now being is liable to be withdrawn at once.
15	The Management is requested to fulfill conditions stipulated in G.O. 1 st read above within 3 months and submit compliance.
16	The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit the same to this office.
17	The Management should follow the provisions of RTE Act.





13. That the society shall submit proposal for renewal of Extension of Temporary recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
15. The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Nellore and District Educational Officer, SPSR Nellore District.
